**FISCAL ANALYSIS**

**ASSUMPTION**

**Section 67.1411 - Community Improvement Districts**

Officials from the **City of Springfield** state the proposed legislation is assumed to not have a substantial fiscal impact on their city.

**Oversight** assumes since the City of Springfield did not provide a fiscal impact, any fiscal impact would be minimal. Therefore, for the purposes of this fiscal note, Oversight will show a zero fiscal impact for this city.

**Oversight** notes the **Missouri Department of Economic Development**, the **Missouri Department of Revenue**, the **Missouri State Auditor's Office**, and the **City of O'Fallon**, and the **City of Kansas City** have each stated this proposed legislation would not have a direct fiscal impact on their respective agencies or cities. Oversight does not have any information to the contrary. Therefore, Oversight will reflect a zero impact on the fiscal note.

Oversight only reflects the responses that we have received from state agencies and political subdivisions; however, other cities and counties were requested to respond to this proposed legislation but did not. A general listing of political subdivisions included in our database is available upon request.

The proposed legislation appears to have no direct fiscal impact.


This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.
