## FISCAL ANALYSIS

### ASSUMPTION

Officials from the **Department of Labor and Industrial Relations** and the **Department of Elementary and Secondary Education** each assume the proposal will have no fiscal impact on their respective organizations.

**Oversight** notes that the above agencies have stated the proposal would not have a direct fiscal impact on their organization. Oversight does not have any information to the contrary. Therefore, Oversight will reflect a zero impact on the fiscal note.

**Oversight** only reflects the responses that we have received from state agencies and political subdivisions; however, the Department of Revenue was requested to respond to this proposed legislation but did not.

**Oversight** notes that the proposal could impact employee wages and therefore could impact income tax collections and earnings tax collections. However, Oversight considers this to be an indirect fiscal impact of the bill and will not reflect it on the fiscal note.
