1 AMEND Senate Bill No. 37, Page 1, Section A, Line 4, by inserting after all of said section and line
2 the following:

3
4 "135.755. 1. For the purposes of this section, the following terms shall mean:

5 (1) "Department", the Missouri department of revenue;

6 (2) "Higher ethanol blend", a fuel capable of being dispensed directly into motor vehicle
7 fuel tanks for consumption that is comprised of at least fifteen percent but no more than eighty-five
8 percent ethanol;

9 (3) "Retail dealer", a person that owns or operates a retail service station;

10 (4) "Retail service station", a location from which higher ethanol blend is sold to the general
11 public and is dispensed directly into motor vehicle fuel tanks for consumption.

12 2. For all tax years beginning on or after January 1, 2022, a retail dealer that sells higher
13 ethanol blend at such retail dealer's retail service station shall be allowed a tax credit to be taken
14 against the retail dealer's state income tax liability. The amount of the credit shall equal five cents
15 per gallon of higher ethanol blend sold by the retail dealer and dispensed through metered pumps at
16 the retail dealer's retail service station during the tax year for which the tax credit is claimed. Tax
17 credits authorized under this section shall not be transferred, sold, or assigned. If the amount of the
18 tax credit exceeds the taxpayer's state tax liability, the difference shall not be refundable, but may be
19 carried forward to any of the five subsequent tax years.

20 3. The tax credit allowed by this section shall be claimed by such taxpayer at the time such
21 taxpayer files a return and shall be applied against the income tax liability imposed by chapter 143
22 after reduction for all other credits allowed thereon. The department may require any
23 documentation it deems necessary to implement the provisions of this section.

24 4. The department shall promulgate rules to implement the provisions of this section. Any
25 rule or portion of a rule, as that term is defined in section 536.010, that is created under the authority
26 delegated in this section shall become effective only if it complies with and is subject to all of the
27 provisions of chapter 536 and, if applicable, section 536.028. This section and chapter 536 are
28 nonseverable, and if any of the powers vested with the general assembly pursuant to chapter 536 to
29 review, to delay the effective date, or to disapprove and annul a rule are subsequently held
30 unconstitutional, then the grant of rulemaking authority and any rule proposed or adopted after
31 August 28, 2021, shall be invalid and void.

32 5. Under section 23.253 of the Missouri sunset act:

33 (1) The provisions of this section shall automatically sunset on December 31, 2025, unless
34 reauthorized by an act of the general assembly;

35 (2) If the provisions of this section are reauthorized, the provisions of this section shall
36 automatically sunset twelve years after the effective date of the reauthorization; and

3 281.015. Sections 281.005 to 281.115 shall be administered by the director of the
 4 department of agriculture of the state of Missouri[, hereafter referred to as the "director"].

5 281.020. As used in sections 281.010 to 281.115, the following terms mean:

6 (1) "Animal", all vertebrate and invertebrate species, including but not limited to man and
 7 other mammals, birds, fish, and shellfish;

8 (2) "Applicator, operator or technician":

9 (a) "Certified applicator", any certified commercial applicator, certified noncommercial
 10 applicator, certified private applicator, certified provisional private applicator, or certified public
 11 operator;

12 (b) "Certified commercial applicator", any individual, whether or not [he] the individual is a
 13 private applicator with respect to some uses, who is certified by the director as authorized to use,
 14 supervise the use of, [or] determine the need for the use of, or supervise the determination of need
 15 for any pesticide, whether classified for restricted use or for general use, while [he] the individual is
 16 engaged in the business of using pesticides on the lands of another as a direct service to the public in
 17 exchange for a fee or compensation;

18 [(b)] (c) "Certified noncommercial applicator", any individual, whether or not [he] the
 19 individual is a private applicator with respect to some uses, who is certified by the director as
 20 authorized to use, or to supervise the use of, any pesticide which is classified for restricted use only
 21 on lands owned or rented by [him] the individual or [his] the individual's employer;

22 [(c)] (d) "Certified private applicator", any individual who is certified by the director as
 23 authorized to use[, or to supervise the use of,] any pesticide [which] that is classified for restricted
 24 use for purposes of producing any agricultural commodity on property owned or rented by [him] the
 25 individual or [his] the individual's employer or on the property of another person, if used without
 26 compensation other than trading of personal services between producers of agricultural
 27 commodities[, on the property of another person];

28 [(d)] (e) "Certified provisional private applicator", any individual who is sixteen or
 29 seventeen years of age, an immediate family member of a certified private applicator, and certified
 30 by the director to use any pesticide that is classified for restricted use for purposes of producing any
 31 agricultural commodity on property owned or rented by the individual's immediate family member,
 32 as long as the following requirements are met:

33 a. The restricted use pesticide is not a fumigant;

34 b. The restricted use pesticide does not contain sodium cyanide or sodium fluoroacetate;

35 c. The individual does not apply any restricted use pesticide using aerial application
 36 equipment;

37 d. The individual does not supervise the use of any restricted use pesticide; and

38 e. The individual does not purchase any restricted use pesticide;

39 (f) "Certified public operator", any individual who is certified by the director as authorized
 40 to use, or to supervise the use of, any pesticide classified for restricted use in the performance of
 41 [his] the individual's duties as an official or employee of any agency of the state of Missouri or any
 42 political subdivision thereof, or any other governmental agency;

43 [(e)] (g) "Noncertified restricted use pesticide applicator", any person who is not certified in
 44 accordance with sections 281.010 to 281.115 who uses or determines the need for the use of
 45 restricted use pesticides under the direct supervision of a certified commercial applicator or uses
 46 restricted use pesticides under the direct supervision of a certified noncommercial applicator or
 47 certified public operator;

48 (h) "Private applicator", any person not holding a certified private applicator's license or
 49 certified provisional private applicator's license who [shall be required to obtain a permit for the use

 8 commercial applicator certified in categories as specified by regulation, and who having met the
 9 competency requirements of ~~[this chapter]~~ sections 281.010 to 281.115, is authorized by the director
 10 to determine the need for the use of any pesticide as well as to the use of any pesticide;

11 ~~[(g)]~~ (j) "Pesticide technician trainee", any individual working in the physical presence and
 12 under the direct supervision of a certified commercial applicator to gain the required on-the-job
 13 training in preparation for obtaining a pesticide technician's license;

14 (3) "Beneficial insects", those insects ~~[which]~~ that, during their life cycle, are effective
 15 pollinators of plants, are parasites or predators of pests, or are otherwise beneficial;

16 (4) "Defoliant", any substance or mixture of substances intended for causing the leaves or
 17 foliage to drop from a plant, with or without causing abscission;

18 (5) "Department" or "department of agriculture", the state department of agriculture, and
 19 when by sections 281.010 to 281.115 the department of agriculture is charged to perform a duty, the
 20 director of the department of agriculture is authorized to perform such duty;

21 (6) "Desiccant", any substance or mixture of substances intended for artificially accelerating
 22 the drying of plant tissue;

23 ~~[(6)]~~ (7) "Determining the need for the use of any pesticide", the act of inspecting land for
 24 the presence of pests for the purpose of contracting for their control or prevention through the use of
 25 pesticides in categories as specified by regulation;

26 ~~[(7)]~~ (8) "Device", any instrument or contrivance, other than a firearm, ~~[which]~~ that is
 27 intended for trapping, destroying, repelling, or mitigating any pest or any other form of plant or
 28 animal life, other than man and other than bacteria, viruses, or other microorganisms on or in living
 29 man or other living animals, but not including equipment used for the application of pesticides when
 30 sold separately therefrom;

31 (9) "Director", the director of the department of agriculture or the director's designee;

32 (10) "Distribute", to sell, offer for sale, hold for sale, deliver for transportation in intrastate
 33 commerce, or transport in intrastate commerce;

34 ~~[(8)]~~ (11) "Environment" includes, but is not limited to, water, air, land, and all plants and
 35 man and other animals living therein, and the interrelationships ~~[which]~~ that exist among these;

36 ~~[(9)]~~ (12) "Equipment" ~~[means]~~ , any type of ground, water, or aerial equipment or
 37 contrivance using motorized, mechanical, or pressurized power and used to apply any pesticide on
 38 land and anything that may be growing, habitating, or stored on or in such land, but shall not include
 39 any pressurized hand-sized household apparatus used to apply any pesticide, or any equipment or
 40 contrivance of which the person who is applying the pesticide is the source of power or energy in

 44 rust, smut, mildew, mold, yeast, and bacteria, except those on or in living man or other living
 45 animals, and except those on or in processed food, beverages, or pharmaceuticals;

46 (14) "General use pesticide", any pesticide, when applied in accordance with its directions
 47 for use, warnings, and cautions, and for the uses for which it is registered, or for one or more of such
 48 uses, or in accordance with a widespread and commonly recognized practice, that will not generally
 49 cause unreasonable adverse effects on the environment;

1 (15) "Immediate family", familial relationships limited to the spouse, parents, stepparents,
 2 foster parents, father-in-law, mother-in-law, children, stepchildren, foster children, sons-in-law,
 3 daughters-in-law, grandparents, brothers, sisters, brothers-in-law, sisters-in-law, aunts, uncles,
 4 nieces, nephews, and first cousins. As used in this subdivision, "first cousin" means the child of a
 5 parent's sibling, i.e., the child of an aunt or uncle;

7 ~~[(12)]~~ (17) "Insect", any of the numerous small invertebrate animals generally having the

 10 allied classes of arthropods whose members are wingless and usually have more than six legs, such

 19 inconsistent with its labeling; provided, that the use of a lesser concentration than provided on the
 20 label shall not be considered the misuse of a pesticide when used strictly for agricultural purposes,
 21 and when requested in writing by the person on whose behalf a pesticide is used;

22 ~~[(15)]~~ (21) "Nematode", invertebrate animals of the phylum Nematelminthes and class
 23 Nematoda, that is, unsegmented round worms with elongated, fusiform, or sac-like bodies covered
 24 with cuticle, and inhabiting soil, water, plants, or plant parts; may also be called nemas or eelworms;

25 (22) "Nontarget organism", any plant, animal, or organism other than the target pests that a
 26 pesticide is intended to affect;

27 ~~[(16)]~~ (23) "Person", any individual, partnership, association, fiduciary, corporation, or any
 28 organized group of persons whether incorporated or not;

29 ~~[(17)]~~ (24) "Pest":

30 (a) Any insect, snail, slug, rodent, nematode, fungus, weed; or

 43 sale, distributed, or sold;

28 281.025. 1. The director shall administer and enforce the provisions of sections 281.010 to
 29 281.115 and shall have authority to issue regulations after a public hearing following due notice of
 30 not less than thirty days to all interested persons, in conformance with the provisions of chapter 536,
 31 to carry out the provisions of sections 281.010 to 281.115. Where the director finds that such
 32 regulations are needed to carry out the purpose and intent of sections 281.010 to 281.115, such
 33 regulations may relate to, but need not be limited to, prescribing the time, place, manner, methods,
 34 materials, and amounts and concentrations, in connection with the use of the pesticide, and may
 35 restrict or prohibit use of pesticides in designated areas during specified periods of time and shall
 36 encompass all reasonable factors ~~[which]~~ that the director deems necessary to prevent damage or
 37 injury. In issuing such regulations, the director may give consideration to pertinent research

 43 ~~and one-time emergency use of a restricted use pesticide by a private applicator.]~~

44 2. The pesticides on the list of restricted use pesticides, as determined by the federal agency
 45 having jurisdiction over the classification of pesticides, shall be so restricted in the state of Missouri.
 46 The director shall publish, at least annually, a list of pesticides ~~[which]~~ that have restricted uses.
 47 Such publication shall be made available to the public upon request. If the director determines that
 48 a pesticide, when used in accordance with its directions for use, warnings, and cautions, and for uses
 49 for which it is registered, may cause, without additional regulatory restrictions, unreasonable

1 adverse effects on the environment, including injury to the applicator or other persons, the pesticide
 2 shall be used only by or under the direct supervision of a certified applicator~~[, or a private applicator~~
 3 ~~with a permit]~~. Such pesticides may be subject to other restrictions as determined by the director, to
 4 include the time and conditions of possession and use.

5 3. No regulation, or any amendment or repeal thereof, provided for in sections 281.010 to
 6 281.115 shall be adopted, except after public hearing giving an opportunity to the public to be heard,
 7 to be held after no less than thirty days' prior notice of the date, time, and place of hearing, to be
 8 given by regular mail to any person who has registered with the director for purposes of notice of
 9 such public hearings, in accordance with procedures prescribed by the director.

10 4. At any hearing, opportunity to be heard shall be afforded to any interested person upon
 11 written request received not later than twenty-four hours prior to the hearing, and may also be
 12 afforded to other persons. In addition, any interested person, whether or not heard, may submit
 13 within seven days subsequent to the hearing a written statement of views. The director may solicit
 14 the views in writing of persons who may be affected by, or interested in any proposed regulation.
 15 Any person heard or represented at the hearing, or making written request for notice, shall be given
 16 written notice of the action of the director with respect to the subject thereof.

17 5. No rule or portion of a rule promulgated under the authority of this chapter shall become
 18 effective unless it has been promulgated pursuant to the provisions of section 536.024.

19 281.030. 1. The director may, by regulation, classify ~~[certified applicator, operator or~~
 20 ~~technician]~~ licenses to be issued under sections 281.010 to 281.115. Such classifications may
 21 include but not be limited to commercial applicators, noncommercial applicators, private
 22 applicators, provisional private applicators, public operators ~~[or]~~, pesticide technicians, or
 23 noncertified RUP applicators. Separate classifications may be specified as to ground, aerial, or
 24 manual methods used by any licensee to apply pesticides or to the use of pesticides for the control of
 25 pests.

26 2. The director may, by regulation, establish certification categories to be provided under
 27 each license classification. Each certification category shall be subject to separate testing
 28 procedures and requirements; provided, that no individual shall be required to pay an additional fee
 29 if ~~[he]~~ the individual is certified in one or all of the certification categories provided under the
 30 license for which ~~[he]~~ the individual has applied. The director may, by regulation, establish
 31 certification categories limited to the use of certain pesticides and issue a license therefor. Each
 32 certification category shall be subject to separate testing procedures covering only those pesticides
 33 for which the applicant seeks to be licensed.

34 3. The director may by regulation establish fees for identification documents.

35 281.035. 1. No individual shall engage in the business of determining the need for the use
 36 of, supervising the use of, supervising the determination of the need for the use of, or using any
 37 pesticide, in categories as specified by regulation, on the lands of another at any time without a
 38 certified commercial applicator's license issued by the director. A certified commercial applicator
 39 shall not determine the need for the use of, supervise the use of, supervise the determination of the
 40 need for the use of, or use any pesticide for any particular purpose unless ~~[he or she]~~ the certified
 41 commercial applicator has demonstrated ~~[his or her]~~ such certified commercial applicator's
 42 competence to use pesticides for that purpose by being certified by the director in the proper
 43 certification category. The director shall require an annual fee of sixty-five dollars for each certified
 44 commercial applicator's license issued. No certified commercial applicator shall knowingly
 45 authorize, direct, or instruct any individual to engage in determining the need for the use of or using
 46 any general use pesticide or minimum risk pesticide on the land of another at any time unless such
 47 individual is a pesticide technician or pesticide technician trainee in such categories as specified by
 48 regulation or is working under the direct supervision of a certified commercial applicator so
 49 authorizing, directing or instructing, in which case the certified commercial applicator shall be liable

1 for any use of a general use pesticide or minimum risk pesticide by an individual operating under
 2 ~~[his or her]~~ the certified commercial applicator's direct supervision. The certified commercial
 3 applicator or the employer shall assure that the director is informed in writing within ten ~~[working]~~
 4 days of the employment of any person as a pesticide technician or pesticide technician trainee.

5 2. No certified commercial applicator shall knowingly authorize, direct, or instruct any
 6 individual to engage in determining the need for the use of or using any restricted use pesticide on
 7 the land of another at any time unless such individual is licensed as a noncertified RUP applicator
 8 while working under the direct supervision of a certified commercial applicator so authorizing,
 9 directing, or instructing, in which case the certified commercial applicator shall be liable for any use
 10 of a restricted use pesticide by an individual operating under the certified commercial applicator's
 11 direct supervision.

12 3. Application for a certified commercial applicator's license shall be ~~[made in writing]~~
 13 submitted to the director on a designated form obtained from the ~~[director's office]~~ department.
 14 Each application shall include such information as prescribed by the director by regulation.

15 ~~[3.]~~ 4. The director shall not issue a certified commercial applicator's license until the
 16 applicant is certified by passing an examination provided by the director to demonstrate to the
 17 director ~~[his or her]~~ the applicant's competence and knowledge of the proper use of pesticides under
 18 the classifications ~~[he or she]~~ the applicant had applied for, and ~~[his or her]~~ the applicant's
 19 knowledge of the standards prescribed by regulations for the certification of commercial applicators.

20 ~~[4.]~~ 5. The director may renew any certified commercial applicator's license under the
 21 classification for which such applicant is licensed, ~~[subject to]~~ upon successful completion of
 22 approved recertification training or reexamination for additional knowledge that may be required to
 23 use pesticides safely and properly either manually or with equipment the applicant has been licensed
 24 to operate.

25 ~~[5.]~~ 6. If the director finds the applicant qualified to use pesticides in the classification for
 26 which application has been made, and if the applicant files evidence that the requirement for bonds
 27 or insurance has been met as required under section 281.065, the director shall issue a certified
 28 commercial applicator's license limited to the classifications for which ~~[he or she]~~ the applicant is
 29 qualified, which shall expire one year from date of issuance unless ~~[it]~~ the license has been revoked
 30 or suspended prior thereto by the director for cause; provided, such financial responsibility required

 37 certified commercial applicator's employer to maintain records with respect to applications of any
 38 pesticide, including pesticides used under direct supervision by licensed pesticide technicians,
 39 pesticide technician trainees, and licensed noncertified RUP applicators. Such relevant information
 40 as the director may deem necessary may be specified by regulation. Such records shall be kept for a
 41 period of three years from the date of the application of the pesticide to which such records refer,
 42 and the director shall, upon request in writing, be furnished with a copy of such records by any
 43 certified commercial applicator or ~~[his or her]~~ the certified commercial applicator's employer.

21 protecting persons who may suffer legal damages as a result of ~~[the operations of]~~ pesticide use by
22 the applicant; except that, such surety bond or liability insurance policy need not apply to damages
23 or injury to crops, plants or land being worked upon by the applicant. Following the receipt of the
24 initial license, the certified commercial applicator shall not be required to furnish evidence of
25 financial responsibility to the department for the purpose of license renewal unless upon request.
26 Annual renewals for surety bonds or liability insurance shall be maintained at the business location

19 2. Any person who claims to have been damaged as a result of a pesticide use and who
20 requests an investigation of that damage by the director shall file with the director, on a form
21 provided by the director, a written statement claiming that ~~[he]~~ the person has been damaged.
22 Damage statements shall be filed within thirty days after the date the damage is alleged to have
23 occurred, unless a growing crop is alleged to have been damaged. If a growing crop is alleged to
24 have been damaged, the damage statement shall be filed at least two weeks prior to the time that
