1 AMEND House Committee Substitute for Senate Substitute No. 2 for Senate Bill No. 26, Page 2,
2 Section 84.400, Line 14, by inserting after said section and line the following:

4 "302.341. 1. If a Missouri resident charged with a moving traffic violation of this state or
5 any county or municipality of this state fails to dispose of the charges of which the resident is
6 accused through authorized prepayment of fine and court costs and fails to appear on the return date
7 or at any subsequent date to which the case has been continued, or without good cause fails to pay
8 any fine or court costs assessed against the resident for any such violation within the period of time
9 specified or in such installments as approved by the court or as otherwise provided by law, any court
10 having jurisdiction over the charges shall within ten days of the failure to comply inform the
11 defendant by ordinary mail at the last address shown on the court records that the court ~~[will]~~ may
12 order the director of revenue to suspend the defendant's driving privileges if the charges are not
13 disposed of and fully paid within thirty days from the date of mailing. Thereafter, if the defendant
14 fails to timely act to dispose of the charges and fully pay any applicable fines and court costs, the
15 court ~~[shall]~~ may notify the director of revenue of such failure and of the pending charges against
16 the defendant. Upon receipt of this notification, the director shall suspend the license of the driver,
17 effective immediately, and provide notice of the suspension to the driver at the last address for the
18 driver shown on the records of the department of revenue. Such suspension shall remain in effect
19 until the court with the subject pending charge requests setting aside the noncompliance suspension
20 pending final disposition, or satisfactory evidence of disposition of pending charges and payment of
21 fine and court costs, if applicable, is furnished to the director by the individual. The filing of
22 financial responsibility with the ~~[bureau of safety responsibility,]~~ department of revenue~~;~~ shall not
23 be required as a condition of reinstatement of a driver's license suspended solely under the
24 provisions of this ~~[section]~~ subsection.

25 2. The provisions of subsection 1 of this section shall not apply to minor traffic violations as
26 defined in section 479.350; however, minor traffic violations shall be subject to subsection 3 of this
27 section.

28 3. If a Missouri resident charged with a minor traffic violation of this state or any county or
29 municipality of this state fails to dispose of the charges of which the resident is accused through
30 authorized prepayment of fine and court costs and fails to appear on two return dates, or without
31 good cause fails to pay any fine or court costs assessed against the resident for any such violation
32 within the period of time specified or in such installments as approved by the court or as otherwise
33 provided by law, any court having jurisdiction over the charges shall, within ten days of the failure
34 to comply, inform the defendant by ordinary mail at the last address shown on the court records that
35 the court may order the director of revenue to suspend the defendant's driving privileges if the
36 charges are not disposed of and fully paid within thirty days from the date of mailing. Thereafter, if

1 the defendant fails to timely act to dispose of the charges and fully pay any applicable fines and
2 court costs, the court may notify the director of revenue of such failure and of the pending charges
3 against the defendant. Upon receipt of this notification, the director shall suspend the license of the
4 driver, effective immediately, and provide notice of the suspension to the driver at the last address
5 for the driver shown on the records of the department of revenue. Such suspension shall remain in
6 effect until the court with the subject pending charge requests setting aside the noncompliance
7 suspension pending final disposition, or satisfactory evidence of disposition of pending charges and
8 payment of fine and court costs, if applicable, is furnished to the director by the individual. The
9 filing of financial responsibility with the department of revenue shall not be required as a condition
10 of reinstatement of a driver's license suspended solely under the provisions of this subsection.

11 4. Where a defendant is charged exclusively with minor traffic violations, as such term is
12 defined in section 479.350, any suspension under this section shall be accompanied by issuance
13 from the director of revenue of limited driving privileges for all purposes identified under
14 subdivision (2) of subsection 3 of section 302.309, unless the director finds the defendant is
15 ineligible for such privileges under the provisions of section 302.309."; and
