1 AMEND House Committee Substitute for House Bill No. 738, Page 7, Section 115.123, Line 21, by
2 inserting after all of said section and line the following:

4 "115.133. 1. Except as provided in subsection 2 of this section, any citizen of the United
5 States who is a resident of the state of Missouri and seventeen years and six months of age or older
6 shall be entitled to register and to vote in any election which is held on or after his eighteenth
7 birthday.

8 2. No person who is adjudged incapacitated shall be entitled to register or vote. No person
9 shall be entitled to vote:

10 (1) While confined under a sentence of imprisonment;

11 (2) While on probation or parole after conviction of a felony, until finally discharged from
12 such probation or parole; or

13 (3) After conviction of a felony or misdemeanor connected with the right of suffrage.

14 3. Except as provided in federal law or federal elections and in ~~[section]~~ sections 115.135
15 and 115.277, no person shall be entitled to vote if the person has not registered to vote in the
16 jurisdiction of his or her residence prior to ~~[the deadline to register to vote]~~ voting.

17 115.135. 1. Any person who is qualified to vote, or who shall become qualified to vote on
18 or before the day of election, shall be entitled to register in the jurisdiction within which he or she
19 resides. In order to vote in any election for which registration is required, a person must be
20 registered to vote ~~[in the jurisdiction of his or her residence no later than 5:00 p.m., or the normal~~
21 ~~closing time of any public building where the registration is being held if such time is later than 5:00~~
22 ~~p.m., on the fourth Wednesday prior to the election, unless the voter is an interstate former resident,~~
23 ~~an intrastate new resident, a new resident, or a covered voter, as defined in section 115.275.~~
24 ~~Except as provided in subsection 4 of this section, in no case shall registration for an election extend~~
25 ~~beyond 10:00 p.m. on the fourth Wednesday prior to the election]~~ on or before the day of the
26 election. The person registering to vote may register to vote via any state-approved online voter
27 registration system, at any location for voter registration established by the secretary of state, or at
28 any election authority or polling place in the jurisdiction of his or her residence on or before the day
29 of the election. Any person registering after such date shall be eligible to vote in subsequent
30 elections.

31 2. A person applying to register with an election authority or a deputy registration official

1 shall identify himself or herself by presenting a copy of a birth certificate, a Native American tribal
2 document, other proof of United States citizenship, a valid Missouri drivers license or other form of
3 personal identification at the time of registration.

4 3. Except as provided in federal law or federal elections and in section 115.277, no person
5 shall be entitled to vote [~~if the person has not registered to vote in the jurisdiction of his or her~~
6 ~~residence prior to the deadline to register to vote~~] in an election unless such person is eligible and
7 properly registered to vote prior to casting their ballot.

8 4. A covered voter as defined in section 115.275 who has been discharged from military
9 service, has returned from a military deployment or activation, or has separated from employment
10 outside the territorial limits of the United States after the deadline to register to vote, and who is
11 otherwise qualified to register to vote, may register to vote in [~~an election in person before the~~
12 ~~election authority until 5:00 p.m. on the Friday before such election. Such persons shall produce~~
13 ~~sufficient documentation showing evidence of qualifying for late registration pursuant to this~~
14 ~~section~~] accordance with the provisions of this chapter."; and
