**AN ACT**

To repeal sections 115.013, 115.031, 115.045, 115.051, 115.085, 115.105, 115.107, 115.123, 115.151, 115.157, 115.160, 115.205, 115.225, 115.237, 115.257, 115.275, 115.277, 115.279, 115.283, 115.285, 115.287, 115.291, 115.302, 115.349, 115.351, 115.417, 115.427, 115.435, 115.447, 115.652, 115.755, 115.758, 115.761, 115.765, 115.767, 115.770, 115.773, 115.776, 115.785, 115.904, and 115.960, RSMo, and to enact in lieu thereof thirty-six new sections relating to elections, with penalty provisions.

*Be it enacted by the General Assembly of the state of Missouri, as follows:*

Section A. Sections 115.013, 115.031, 115.045, 115.051, 115.085, 115.105, 115.107, 115.123, 115.151, 115.157, 115.160, 115.205, 115.225, 115.237, 115.257, 115.275, 115.277, 115.279, 115.283, 115.285, 115.287, 115.291, 115.302, 115.349, 115.351, 115.417, 115.427, 115.435, 115.447, 115.652, 115.755, 115.758, 115.761, 115.765, 115.767, 115.770, 115.773, 115.776, 115.785, 115.904, and 115.960, RSMo, are repealed and thirty-six new sections enacted in lieu thereof, to be known as sections 28.960, 115.004, 115.013, 115.031, 115.045, 115.051, 115.085, 115.105, 115.107, 115.123, 115.151, 115.157, 115.160, 115.205, 115.225, 115.237, 115.257, 115.275, 115.277, 115.279, 115.283, 115.285, 115.286, 115.287, 115.291, 115.349, 115.351, 115.417, 115.427, 115.435, 115.447, 115.652, 115.904, 115.960, 1, and 2, to read as follows:

**28.960. 1. The secretary of state shall have the authority to, at his or her discretion, audit the list of registered voters for any election authority to ensure accuracy.**

**2. The secretary of state shall provide at least five business days' notice to the election authority that he or she intends to inspect the list of voter registration records. Such notice may be sent electronically.**

EXPLANATION — Matter enclosed in bold-faced brackets [thus] in the above bill is not enacted and is intended to be omitted from the law. Matter in **bold-face** type in the above bill is proposed language.

6           **3. The audits conducted by the secretary of state shall, at a minimum, verify the**  
7 **following:**

8           **(1) That a registered voter is alive;**

9           **(2) That a registered voter currently resides within the jurisdiction of election**  
10 **authority; and**

11           **(3) That a registered voter is entitled to vote.**

12           **4. If names are found that do not meet the criteria in subsection 3 of this section,**  
13 **the secretary of state shall instruct the election authority to remove the names from the list**  
14 **of registered voters. The secretary of state may conduct a second audit to ensure the names**  
15 **were removed.**

16           **5. The election authority shall comply with the secretary of state's office in**  
17 **conducting the audit and shall remove the names identified by the secretary of state. If an**  
18 **election authority does not cooperate with the audit, the secretary of state's office may**  
19 **withhold funds from the election authority.**

**115.004. The sections of this chapter and all related rules and regulations shall not**  
2 **be amended or modified in any manner in the twenty-six weeks preceding a presidential**  
3 **election.**

          115.013. As used in this chapter, unless the context clearly implies otherwise, the  
2 following terms mean:

3           (1) "Automatic tabulating equipment", the apparatus necessary to examine and  
4 automatically count votes, and the data processing machines which are used for counting votes  
5 and tabulating results **and is air gapped and not connected to a network;**

6           (2) "Ballot", the ~~[ballot card,]~~ paper ballot, or ballot designed for use with an electronic  
7 voting system on which each voter may cast all votes to which he or she is entitled at an election;

8           (3) ~~["Ballot card", a ballot which is voted by making a mark which can be tabulated by~~  
9 ~~automatic tabulating equipment;~~

10           ~~(4)~~ "Ballot label", the card, paper, booklet, page, or other material containing the names  
11 of all offices and candidates and statements of all questions to be voted on;

12           ~~[(5)]~~ (4) "Counting location", a location selected by the election authority for the  
13 automatic processing or counting, or both, of ballots;

14           ~~[(6)]~~ (5) "County", any county in this state or any city not within a county;

15           ~~[(7)]~~ (6) "Disqualified", a determination made by a court of competent jurisdiction, the  
16 Missouri ethics commission, an election authority or any other body authorized by law to make  
17 such a determination that a candidate is ineligible to hold office or not entitled to be voted on for  
18 office;

19           ~~[(8)]~~ (7) "District", an area within the state or within a political subdivision of the state  
20 from which a person is elected to represent the area on a policy-making body with  
21 representatives of other areas in the state or political subdivision;

22           ~~[(9)]~~ (8) "Electronic voting machine", any part of an electronic voting system on which  
23 a voter is able to cast a ballot under this chapter;

24           ~~[(10)]~~ (9) "Electronic voting system", a system of casting votes by use of marking  
25 devices, and counting votes by use of automatic tabulating or data processing equipment,  
26 including computerized voting systems;

27           ~~[(11)]~~ (10) "Established political party" for the state, a political party which, at either of  
28 the last two general elections, polled for its candidate for any statewide office more than two  
29 percent of the entire vote cast for the office. "Established political party" for any district or  
30 political subdivision shall mean a political party which polled more than two percent of the entire  
31 vote cast at either of the last two elections in which the district or political subdivision voted as  
32 a unit for the election of officers or representatives to serve its area;

33           ~~[(12)]~~ (11) "Federal office", the office of presidential elector, United States senator, or  
34 representative in Congress;

35           ~~[(13)]~~ (12) "Independent", a candidate who is not a candidate of any political party and  
36 who is running for an office for which political party candidates may run;

37           ~~[(14)]~~ (13) "Major political party", the political party whose candidates received the  
38 highest or second highest number of votes at the last general election;

39           ~~[(15)]~~ (14) "Marking device", any approved device which will enable the votes to be  
40 counted by automatic tabulating equipment;

41           ~~[(16)]~~ (15) "Municipal" or "municipality", a city, village, or incorporated town of this  
42 state;

43           ~~[(17)]~~ (16) "New party", any political group which has filed a valid petition and is  
44 entitled to place its list of candidates on the ballot at the next general or special election;

45           ~~[(18)]~~ (17) "Nonpartisan", a candidate who is not a candidate of any political party and  
46 who is running for an office for which party candidates may not run;

47           ~~[(19)]~~ (18) "Political party", any established political party and any new party;

48           ~~[(20)]~~ (19) "Political subdivision", a county, city, town, village, or township of a  
49 township organization county;

50           ~~[(21)]~~ (20) "Polling place", the voting place designated for all voters residing in one or  
51 more precincts for any election;

52           ~~[(22)]~~ (21) "Precincts", the geographical areas into which the election authority divides  
53 its jurisdiction for the purpose of conducting elections;

54           [(23)] (22) "Public office", any office established by constitution, statute or charter and  
55 any employment under the United States, the state of Missouri, or any political subdivision or  
56 special district thereof, but does not include any office in the Missouri state defense force or the  
57 National Guard or the office of notary public or city attorney in cities of the third classification  
58 or cities of the fourth classification;

59           [(24)] (23) "Question", any measure on the ballot which can be voted "YES" or "NO";

60           [(25)] (24) "Relative within the second degree by consanguinity or affinity", a spouse,  
61 parent, child, grandparent, brother, sister, grandchild, mother-in-law, father-in-law, daughter-in-  
62 law, or son-in-law;

63           [(26)] (25) "Special district", any school district, water district, fire protection district,  
64 hospital district, health center, nursing district, or other districts with taxing authority, or other  
65 district formed pursuant to the laws of Missouri to provide limited, specific services;

66           [(27)] (26) "Special election", elections called by any school district, water district, fire  
67 protection district, or other district formed pursuant to the laws of Missouri to provide limited,  
68 specific services; and

69           [(28)] (27) "Voting district", the one or more precincts within which all voters vote at  
70 a single polling place for any election.

115.031. Each election commissioner shall be a registered voter and a resident of the  
2 jurisdiction for which he is appointed [~~for at least one year preceding his appointment~~]. During  
3 his term of office, no commissioner shall hold any statutory position within a political party or  
4 on a political committee, be a candidate for political office or hold any other public office.

115.045. Each election authority shall have the authority to employ such attorneys and  
2 other employees as may be necessary to promptly and correctly perform the duties of the election  
3 authority. Where an electronic voting system or voting machines are used, the election authority  
4 shall designate competent employees to have custody of and supervise maintenance of the voting  
5 equipment. Board of election commissioners' employees shall be subject to the same restrictions  
6 and subscribe the same oath as members of the board of election commissioners, except that no  
7 employee of a board of election commissioners shall be required to post bond **or reside and be**  
8 **a registered voter within the jurisdiction of the election authority** unless directed to do so  
9 by the board. Employee oaths and any bonds shall be filed and preserved in the office of the  
10 board.

115.051. 1. In each county which does not have a board of election commissioners, the  
2 county clerk shall have the right to employ such deputies and assistants as are necessary to  
3 promptly and correctly register voters and conduct elections. Where an electronic voting system  
4 or voting machines are used, the county clerk shall designate competent employees to have  
5 custody of and supervise maintenance of the voting equipment. Each deputy shall be subject to

6 the same restrictions and subscribe the same oath as the county clerk, except that no employee  
7 shall be required to post bond **or reside and be a registered voter within the jurisdiction of**  
8 **the election authority** unless directed to do so by the clerk. Employee oaths and any bonds shall  
9 be filed and preserved in the office of the county clerk.

10 2. Within the total amount for deputies and assistants approved by the county  
11 commission, the salary of each deputy and assistant shall be set by the county clerk.

115.085. No person shall be appointed to serve as an election judge who is not a  
2 registered voter in this state; provided that, ~~[before]~~ any election authority may appoint judges  
3 who are registered voters of another election authority's jurisdiction~~[-the election authority shall~~  
4 ~~obtain the written consent of the election authority for the jurisdiction where the prospective~~  
5 ~~judges are registered to vote]~~. Each election judge shall be a person of good repute and character  
6 who can speak, read, and write the English language. No person shall serve as an election judge  
7 at any polling place in which his or her name or the name of a relative within the second degree,  
8 by consanguinity or affinity, appears on the ballot. However, no relative of any unopposed  
9 candidate shall be disqualified from serving as an election judge in any election jurisdiction of  
10 the state. No election judge shall, during his or her term of office, hold any other elective public  
11 office, other than as a member of a political party committee or township office, except any  
12 person who is elected to a board or commission of a political subdivision or special district may  
13 serve as an election judge except at a polling place where such political subdivision or special  
14 district has an issue or candidate on the ballot. In any county having a population of less than  
15 two hundred fifty thousand inhabitants, any candidate for the county committee of a political  
16 party who is not a candidate for any other office and who is unopposed for election as a member  
17 of the committee shall not be disqualified from serving as an election judge.

115.105. 1. The chair of the county committee of each political party named on the  
2 ballot shall have the right to designate a challenger for each polling place, who may be present  
3 until all ballots are cast on the day of election, and a challenger for each location at which  
4 absentee ballots are counted, who may be present while the ballots are being prepared for  
5 counting and counted. No later than four business days before the election, the chair of each  
6 county committee of each political party named on the ballot shall provide signed official  
7 designation forms with the names of the designated challengers and substitutes to the local  
8 election authority for confirmation of eligibility to serve as a challenger. The local election  
9 authority, after verifying the eligibility of each designated and substitute challenger, shall sign  
10 off on the official designation forms, unless the challenger is found not to have the qualifications  
11 established by subsection ~~[5]~~ 4 of this section. If the election authority determines that a  
12 challenger does not meet the qualifications of subsection ~~[5]~~ 4 of this section, the designating  
13 party chair may designate a replacement challenger and provide the local election authority with

14 the name of the replacement challenger before 5:00 p.m. of the Monday preceding the election.  
15 The designating chair may substitute challengers at his or her discretion during such hours.

16 2. Challenges may only be made when the challenger believes the election laws of this  
17 state have been or will be violated, and each challenger shall report any such belief to the  
18 election judges, or to the election authority if not satisfied with the decision of the election  
19 judges.

20 3. Prior to the close of the polls, challengers may list and give out the names of those  
21 who have voted. The listing and giving out of names of those who have voted by a challenger  
22 shall not be considered giving information tending to show the state of the count.

23 4. ~~[In a presidential primary election, challengers may collect information about the party~~  
24 ~~ballot selected by the voter and may disclose party affiliation information after the polls close.~~  
25 ~~5.]~~ All persons selected as challengers shall have the same qualifications required by  
26 section 115.085 for election judges, except that such challenger shall be a registered voter in the  
27 jurisdiction of the election authority for which the challenger is designated as a challenger.

28 ~~[6.]~~ 5. Any challenge by a challenger to a voter's identification for validity shall be made  
29 only to the election judges or other election authority. If the poll challenger is not satisfied with  
30 the decision of the election judges, then he or she may report his or her belief that the election  
31 laws of this state have been or will be violated to the election authority as allowed under this  
32 section.

115.107. 1. At every election, the chairman of the county committee of each political  
2 party named on the ballot shall have the right to designate a watcher for each place votes are  
3 counted.

4 2. Watchers are to observe the counting of the votes and present any complaint of  
5 irregularity or law violation to the election judges, or to the election authority if not satisfied with  
6 the decision of the election judges. No watcher may be substituted for another on election day.

7 3. No watcher shall report to anyone the name of any person who has or has not voted.

8 4. A watcher may remain present until all closing certification forms are completed, all  
9 equipment is closed and taken down, the transportation case for the ballots is sealed, election  
10 materials are returned to the election authority or to the designated collection place for a polling  
11 place, and any other duties or procedures required under sections 115.447 to 115.491 are  
12 completed. A watcher may also remain present at each location at which absentee ballots are  
13 counted and may remain present while such ballots are being prepared for counting and counted.

14 5. All persons selected as watchers shall have the same qualifications required by section  
15 115.085 for election judges, except that such watcher shall be a registered voter in the  
16 jurisdiction of the election authority for which the watcher is designated as a watcher.

17           **6. A candidate may select his or her own poll watchers at his or her own expense,**  
18 **provided that the poll watchers meet the other requirements of this section.**

115.123. 1. All public elections shall be held on Tuesday. Except as provided in  
2 subsections 2 and 3 of this section, and section 247.180, all public elections shall be held on the  
3 general election day, the primary election day, the general municipal election day, the first  
4 Tuesday after the first Monday in November, or on another day expressly provided by city or  
5 county charter, and in nonprimary years on the first Tuesday after the first Monday in August.  
6 Bond elections may be held on the first Tuesday after the first Monday in February but no other  
7 issue shall be included on the ballot for such election.

8           2. ~~Notwithstanding the provisions of subsection 1 of this section, an election for a~~  
9 ~~presidential primary held pursuant to sections 115.755 to 115.785 shall be held on the second~~  
10 ~~Tuesday after the first Monday in March of each presidential election year.~~

11 ~~3.]~~ The following elections shall be exempt from the provisions of subsection 1 of this  
12 section:

- 13           (1) Bond elections necessitated by fire, vandalism or natural disaster;
- 14           (2) Elections for which ownership of real property is required by law for voting;
- 15           (3) Special elections to fill vacancies and to decide tie votes or election contests; and
- 16           (4) Tax elections necessitated by a financial hardship due to a five percent or greater  
17 decline in per-pupil state revenue to a school district from the previous year.

18           ~~4.]~~ 3. Nothing in this section prohibits a charter city or county from having its primary  
19 election in March if the charter provided for a March primary before August 28, 1999.

20           ~~5.]~~ 4. Nothing in this section shall prohibit elections held pursuant to section 65.600,  
21 but no other issues shall be on the March ballot except pursuant to this chapter.

115.151. 1. Each qualified applicant who appears before the election authority shall be  
2 deemed registered as of the time the applicant's completed, signed and sworn registration  
3 application is witnessed by the election authority or deputy registration official.

4           2. Each applicant who registers by mail shall be deemed to be registered as of the date  
5 the application is postmarked, if such application is accepted and not rejected by the election  
6 authority and the verification notice required pursuant to section 115.155 is not returned as  
7 undeliverable by the postal service.

8           3. Each applicant who registers at a voter registration agency or the division of motor  
9 vehicle and drivers licensing of the department of revenue shall be deemed to be registered as  
10 of the date the application is signed by the applicant, if such application is accepted and not  
11 rejected by the election authority and the verification notice required pursuant to section 115.155  
12 is not returned as undeliverable by the postal service. Voter registration agencies ~~and the~~  
13 ~~division of motor vehicle and drivers licensing of the department of revenue]~~ shall transmit voter

14 registration application forms to the appropriate election authority not later than five business  
15 days after the form is completed by the applicant. **The division of motor vehicle and drivers  
16 licensing of the department of revenue shall transmit voter registration application forms  
17 to the appropriate election authority not later than three business days after the form is  
18 completed by the applicant.**

115.157. 1. The election authority may place all information on any registration cards  
2 in computerized form in accordance with section 115.158. No election authority or secretary of  
3 state shall furnish to any member of the public electronic media or printout showing any  
4 registration information, except as provided in this section. Except as provided in subsection 2  
5 of this section, the election authority or secretary of state shall make available electronic media  
6 or printouts showing **only** unique voter identification numbers, voters' names, [~~dates of birth,~~  
7 addresses, townships or wards, and precincts. Electronic data shall be maintained in at least the  
8 following separate fields:

- 9 (1) Voter identification number;
- 10 (2) First name;
- 11 (3) Middle initial;
- 12 (4) Last name;
- 13 (5) Suffix;
- 14 (6) Street number;
- 15 (7) Street direction;
- 16 (8) Street name;
- 17 (9) Street suffix;
- 18 (10) Apartment number;
- 19 (11) City;
- 20 (12) State;
- 21 (13) Zip code;
- 22 (14) Township;
- 23 (15) Ward;
- 24 (16) Precinct;
- 25 (17) Senatorial district;
- 26 (18) Representative district;
- 27 (19) Congressional district.

28 2. All election authorities shall enter voter history in their computerized registration  
29 systems and shall, not more than six months after the election, forward such data to the Missouri  
30 voter registration system established in section 115.158. In addition, election authorities shall



31 forward registration and other data in a manner prescribed by the secretary of state to comply  
32 with the Help America Vote Act of 2002.

33 3. Except as provided in subsection 6 of this section, the election authority shall furnish,  
34 for a fee, electronic media or a printout showing **only** the names~~[-, dates of birth]~~ and addresses  
35 of voters, or any part thereof, within the jurisdiction of the election authority who voted in any  
36 specific election, including primary elections, by township, ward or precinct, provided that  
37 nothing in this chapter shall require such voter information to be released to the public over the  
38 internet **and shall not be used for commercial purposes.**

39 4. ~~[Except as provided in subsection 6 of this section, upon a request by a candidate, a~~  
40 ~~duly authorized representative of a campaign committee, or a political party committee, the~~  
41 ~~secretary of state shall furnish, for a fee determined by the secretary of state and in compliance~~  
42 ~~with section 610.026, media in an electronic format or, if so requested, in a printed format,~~  
43 ~~showing the names, addresses, and voter identification numbers of voters within the jurisdiction~~  
44 ~~of a specific election authority who applied for an absentee ballot under section 115.279 for any~~  
45 ~~specific election involving a ballot measure or an office for which the declaration of candidacy~~  
46 ~~is required to be filed with the secretary of state pursuant to section 115.353, including primary~~  
47 ~~elections, by township, ward, or precinct. Nothing in this section shall require such voter~~  
48 ~~information to be released to the public over the internet. For purposes of this section, the terms~~  
49 ~~"candidate", "campaign committee", and "political party committee" shall have the same~~  
50 ~~meaning given to such terms in section 130.011.~~

51 ~~———5.] The amount of fees charged for information provided in this section shall be~~  
52 ~~established pursuant to chapter 610. All revenues collected by the secretary of state pursuant to~~  
53 ~~this section shall be deposited in the state treasury and credited to the secretary of state's~~  
54 ~~technology trust fund account established pursuant to section 28.160. [In even-numbered years,~~  
55 ~~each election authority shall, upon request, supply the voter registration list for its jurisdiction~~  
56 ~~to all candidates and party committees for a charge established pursuant to chapter 610. Except~~  
57 ~~as provided in subsection 6 of this section, all election authorities shall make the information~~  
58 ~~described in this section available pursuant to chapter 610. Any election authority who fails to~~  
59 ~~comply with the requirements of this section shall be subject to the provisions of chapter 610.]~~

60 ~~[6.]~~ 5. Any person working as an undercover officer of a local, state or federal law  
61 enforcement agency, persons in witness protection programs, and victims of domestic violence  
62 and abuse who have received orders of protection pursuant to chapter 455 shall be entitled to  
63 apply to the circuit court having jurisdiction in his or her county of residence to have the  
64 residential address on his or her voter registration records closed to the public if the release of  
65 such information could endanger the safety of the person. Any person working as an undercover  
66 agent or in a witness protection program shall also submit a statement from the chief executive

67 officer of the agency under whose direction he or she is serving. The petition to close the  
68 residential address shall be incorporated into any petition for protective order provided by circuit  
69 clerks pursuant to chapter 455. If satisfied that the person filing the petition meets the  
70 qualifications of this subsection, the circuit court shall issue an order to the election authority to  
71 keep the residential address of the voter a closed record and the address may be used only for the  
72 purposes of administering elections pursuant to this chapter. The election authority may require  
73 the voter who has a closed residential address record to verify that his or her residential address  
74 has not changed or to file a change of address and to affirm that the reasons contained in the  
75 original petition are still accurate prior to receiving a ballot. A change of address within an  
76 election authority's jurisdiction shall not require that the voter file a new petition. Any voter who  
77 no longer qualifies pursuant to this subsection to have his or her residential address as a closed  
78 record shall notify the circuit court. Upon such notification, the circuit court shall void the order  
79 closing the residential address and so notify the election authority.

115.160. 1. All Missouri driver's license applicants shall receive a voter registration  
2 application form as a simultaneous part of the application for a driver's license, renewal of  
3 driver's license, change of address, duplicate request and a nondriver's license.

4 2. If a single application form is used, the voter registration application portion of any  
5 application described in subsection 1 of this section may not require any information that  
6 duplicates information required in the driver's license portion of the form, except a second  
7 signature or other information required by law.

8 3. After conferring with the secretary of state as the chief state election official  
9 responsible for overseeing of the voter registration process, the director of revenue shall adopt  
10 rules and regulations pertaining to the format of the voter registration application used by the  
11 department. **The director of revenue shall utilize electronic voter registration application**  
12 **forms and provide for secure electronic transfer of voter registration information to**  
13 **election authorities. The secretary of state and the director of revenue shall ensure the**  
14 **confidentiality and integrity of the voter registration data collected, maintained, received,**  
15 **or transmitted under this section.**

16 4. No information relating to the failure of an applicant for a driver's license or  
17 nondriver's license to sign a voter registration application may be used for any purpose other than  
18 voter registration.

19 5. Any voter registration application received pursuant to the provisions of this section  
20 shall be forwarded, **in a secure and electronic manner**, to the election authority located within  
21 that county or any city not within a county, or if there is more than one election authority within  
22 the county, then to the election authority located nearest to the location where the driver's license  
23 application was received. **Voter registration information, including an electronic image of**

24 **the signature of the applicant, shall be transmitted in a format compatible with the**  
 25 **Missouri voter registration system established in section 115.158 which allows for review**  
 26 **by the election authority and does not require the election authority to manually reenter**  
 27 **the information.** The election authority receiving the application forms shall review the  
 28 applications and forward, **in a secure and electronic manner**, any applications pertaining to a  
 29 different election authority to that election authority.

30 6. A completed voter registration application accepted in the driver's licensing process  
 31 shall be transmitted to the election authority described in subsection 5 of this section not later  
 32 than five business days after the form is completed by the applicant.

33 7. Any person registering to vote when applying for or renewing a Missouri driver's  
 34 license shall submit with the application form a copy of a birth certificate, a Native American  
 35 tribal document, or other proof of United States citizenship, a valid Missouri driver's license, or  
 36 other form of personal identification.

115.205. 1. ~~[Any]~~ **No person [who is] shall be paid or otherwise compensated for**  
 2 **soliciting [more than ten] voter registration applications, other than a governmental entity or a**  
 3 **person who is paid or compensated by a governmental entity for such solicitation[; shall be**  
 4 **registered with the secretary of state as a voter registration solicitor].** A voter registration  
 5 solicitor **who solicits more than ten voter registration applications** shall register for every

21 when the number of votes exceeds the number a voter is lawfully entitled to cast;

22 (9) Permits each voter, while voting, to clearly see the ballot label;

23 (10) Has been tested and is certified by an independent authority that meets the voting  
24 system standards developed by the Federal Election Commission or its successor agency. The  
25 provisions of this subdivision shall not be required for any system purchased prior to August 28,  
26 2002.

27 3. The secretary of state shall promulgate rules and regulations to allow the use of a

The preparation shall be watched by two observers designated by the election authority, one from each major political party, and shall be open to representatives of the political parties, candidates, the news media and the public.

3. When an electronic voting machine has been examined by such observers and shown to be in good working order, the machine shall be locked against voting. The observers shall certify the vote count on each machine is set at zero.

4. After an electronic voting machine has been properly prepared and locked, its keys shall be retained by the election authority and delivered to the election judges along with the other election supplies.

5. For the purpose of processing absentee ballots, cast by voters in person in the office of the election authority **that is deemed a designated polling place**, the election authority ~~may~~ **shall** cause voting machines, **if used**, to be put in order, set, adjusted, tested, and made ready for voting within one business day of the printing of absentee ballots as provided in section 115.281. The election authority shall have the recording counter except for the protective counter on the voting machine set to zero (000). After the voting machines have been made ready for voting, the election authority shall not permit any person to handle any voting machine, except voters while they are voting and others expressly authorized by the election authority. The election authority shall neither be nor permit any other person to be in any position or near any position that enables the authority or person to see how any absentee voter votes or has voted.

6. Nothing in this section shall prohibit the on-site storage of electronic voting machines and the preparation of the electronic machines for voting, provided the electronic voting machines are put in order, set, adjusted and made ready for voting as provided in subsections 1, 2, 3, 4, and 5 of this section.
