

HB 1878 -- ELECTIONS

SPONSOR: Simmons

COMMITTEE ACTION: Voted "Do Pass" by the Standing Committee on Elections and Elected Officials by a vote of 8 to 4. Voted "Do Pass" by the Standing Committee on Rules- Administrative Oversight by a vote of 9 to 4.

This bill modifies election laws. In its main provisions the bill:

(1) Requires persons voting in person by use of an absentee ballot to establish their identity under Section 115.427, RSMo;

(2) Allows voters without personal identification at a polling place to vote a provisional ballot which will be counted based upon a certification process and the return of documentation or by a signature verification process conducted by the election authority; and

(3) Repeals certain affidavit and notice requirements under Section 115.427.

This bill is the same as HB 334 (2021).

PROPOSERS: Supporters say that the bill will repeal problematic affidavit sections held unconstitutional by the Missouri Supreme Court and otherwise modify photographic identification requirements in a reasonable manner. In person absentee voting will require the use of such identification. The provisional ballot exceptions to the photographic identification requirement will remain in place and so properly registered voters may vote by provisional ballot if they lack photographic identification at the polling place.

Many empirical studies show that voter turnout is not effected at all by identification requirements. The Missouri Secretary of State's office has a perfect track record of helping all individuals acquire photographic identification and will pay for the necessary documents. All of Europe makes use of photographic identification for voting and many states also require identification. It is a good practice to prevent or reduce any kind of voter fraud.

OPPONENTS: Those who oppose the bill say that they are opposed to any regulation that makes voting more difficult. There have been no cases of voter impersonation fraud since approximately 2006. The Missouri Secretary of State should be required to provide notice of photographic identification requirements and the removal of notice requirements is a bad bargain designed to reduce the cost of the legislation. The signature matching process for provisional ballots is unreliable and not objective. Older individuals often lack both identification and documents and it can take a long time to correct such issues.

The Missouri Supreme Court has indicated that allowing only

government issued photographic identification for voting is unconstitutional. A 2016 Constitutional amendment does not explicitly authorize only the use of photographic identification, and this legislation is still subject to Constitutional challenges in state court.
