HB 2862 -- MINERAL INTERESTS

SPONSOR: Sassmann

This bill specifies that any mineral interest lapses if unused for 20 years unless a statement of claim is filed in accordance with the bill. If a mineral interest lapses, ownership reverts to the current surface landowner.
