The Associations encourages the legislature to authorize the spending of the ESSER III funding allocations as soon as possible this session. This will ensure that DESE and school districts know that they can rely on the federal funds for the implementation of their ESSER III plans. Approving the funds quickly also ensures that there is adequate time to plan and use those funds to the best advantage in serving the needs of students and addressing learning loss.
